## PROCEDURE CANCELLATION NOTICE

## Concerns: Delivery of a projection welder for TO packages – ref. No. F2/17/2022.

Acting pursuant to Art. 260 Par. 2 of the Public Procurement Law Act (Journal of Laws of 2019, item 2019 with subsequent amendments), hereinafter referred to as "PPL", the Contracting Entity hereby notifies of the cancellation of the procedure.

**Legal grounds:** Art. 255 Par. 2 of the PPL, i.e. all submitted requests for participation in the proceedings or tenders have been subject to rejection.

**Factual grounds**: The bid submitted by the Contractor Pyramid Engineering Services Company Limited Unit 5, M2M Park, Fort Bridgewood, Rochester, Kent, ME1 3DQ, UNITED KINGDOM is subject to rejection pursuant to Art. 226 paragraph. 1 point 3 - its content is inconsistent with the provisions of the Act.

The Contractor submitted a bid that was not signed with a qualified electronic signature required in accordance with the provisions of the PPL Act and with the Terms of Reference.

After decrypting the file, the Contracting Entity validated it (checking whether the bid was signed). As a result of the verification of the correctness of the signatures, the Contracting Entity received the electronic signature verification report: "Signature verification status: Signature not verifiable. Inability to build a certification path; Type of signature: not qualified ".

Pursuant to Art. 63 sec. 2 of the Act of September 11, 2019 (Journal of Laws of 2019, item 2019, as amended) in a procurement procedure or in a design contest with a value equal to or exceeding the EU-thresholds **tender**, a request to participate in a procurement procedure or in a design contest, the request referred to in Article 371 para. 3, and the statement referred to in Article 125 para. 1, **shall be submitted, under pain of nullity, in an electronic form**.

Pursuant to Chapter XII point 1 of the ToR - the bid must be prepared in electronic form.

The electronic form should be understood in accordance with the content of art. 781 § 1 of the Civil Code as an electronic form with a qualified electronic signature.
